Handicap Accessible Beach Mat Discussed that we should have the first 100 feet of the mat to be concrete and the last 50 feet will be the actual Mat. McGuire is to go to the Pardeeville Village Trustees to see if we can use Concrete as well the actual Mat. Our Goal is to have everything done before Memorial Day weekend.: PLMD will provide the funds for One 50-foot Mobility Mat with 100 feet of Concrete sidewalk from the Handicap parking to the Beach, upon Village approval. The motion as stated in the meeting by Levzow was " I make a Motion to put in 1 section of handicap accessible beach mat which is 50' long. Then to have a 100' cement sidewalk 5' wide poured from the parking lot to meet the start of the beach mat which would not exceed a total cost of \$9,000. Trumbower seconded the motion. Motion carried unanimously.
